## B. Criteria for Selection:

- 1. Candidates qualifying in Stage-I shall be eligible to appear in Stage-II.
- Only such candidates who qualify in each paper of Stage-I shall be considered for for preparation of final merit list.
- Final merit list of the qualified candidates shall be prepared on the basis of total marks secured by the candidates in both the stages of examination.
- After arranging the candidates in order of merit as per ( c) above, number of candidates to be declared successful shall be equal to the number of vacancies in each category.
- In the event of any vacancy notified for recruitment remains unfilled only due to nonjoining of selected candidate, the next candidate in the merit list shall be considered for appointment. However, appointment of such candidate shall be only on the ground of declining offer of appointment and no waitlist or approved panel shall be maintained.

Note: The date and venue of the tests will be intimated separately to the eligible candidates. No intimation will be sent in respect of other applicants who are not eligible.

## 9. Disqualification: No person,-

(a) who, has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this Rule.

#### 10. Disclaimer:

- (i) The Department of Posts reserves the right to cancel this recruitment process without assigning any reason.
- (ii) The vacancies notified are subject to change without assigning any reason and Department reserves the right to cancel the recruitment.

## 11. Special instructions to the candidates

- The candidate should fill up all the fields of the application form. No column should be left blank.
- ii. One envelope should contain one application only.
- The application complete in all respect should be sent through SPEEDPOST/REGISTERED POST only. Application received through other means will not be accepted.
- Applications received after due date will not be entertained under any circumstances.
- No allowances and expenses will be paid for attending the test and the candidates will have to bear the cost.

- vII. Community Certificate for SC/ST/OBC/EWS in the prescribed form issued from the competent authority is to be submitted. Certificates submitted in any other form or from authorities not competent to issue the same will not be accepted.


